ATTENTION TAXPAYERS:

REAL ESTATE ITEMS ON WHICH TAXES ARE DELINQUENT FOR TWO (2) CONSECUTIVE TAX PAYING PERIODS ARE DELINQUENT ON THE TAX DUPLICATE. THE COUNTY PROSECUTOR IS REQUIRED BY LAW TO COLLECT DELINQUENT TAXES BY FORECLOSURE ACTION AND SHERIFFS SALES. YOU MAY PAY YOUR TAXES BY MAIL, IF YOU COME IN PERSON TO THE TREASURERS OFFICE PLEASE PROVIDE YOUR TAX STATEMENT. IF CHECKS RECEIVED FOR TAXES ARE RETURNED UNPAID, THE TAXES WILL BE RESTORED TO THE DUPLICATE AND A PENALTY WILL BE ADDED WITHOUT FURTHER NOTICE.
